Nutritious snacks were distributed to clients through area service partners.

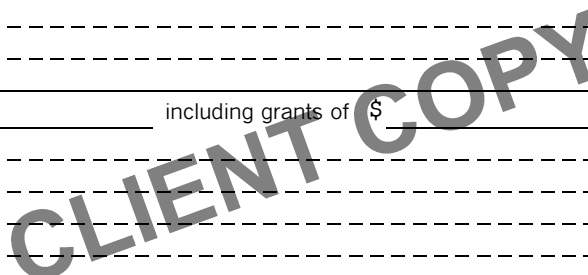

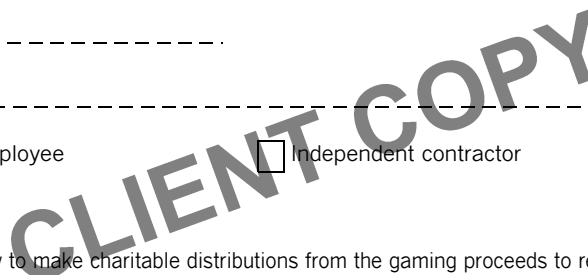
